Areas of Application

SikaGard®-6215 has excellent water-repellent and penetrating properties. It protects against rust and corrosion in concealed areas such as door skins inside, rear wing panels, sills and chassis legs. After drying a translucent, slightly sticky wax coating with self-healing properties remains.

Method of Application

Surface preparation

Surfaces must be clean, dry, rust-, dust- and grease free.

Advice on specific applications is available from the Technical Service Department of Sika Industry.

Application

Shake can vigorously before use. Cover adjoining surfaces. Spray at room temperature and from a distance of approximately 30 cm on the surface or in the cavity using a flexible ML hose. Spray a continuous coat.

After use, invert can and spray in short bursts to clear nozzle.

Removal

Fresh SikaGard[®]-6215 can be removed from tools and equipment with Sika[®] Remover-208. Once dried, the material can only be removed mechanically.

Hands and exposed skin should be washed immediately using Sika[®] Handclean towels or a suitable industrial hand cleaner and water. Do not use solvents!

Overpainting

SikaGard[®]-6215 is not overpaintable.
