# LIMITATIONS

- Freshly applied Sikafloor<sup>®</sup> products must be protected from damp, condensation and water for at least 24 hours.
- Uncured material reacts in contact with water (foam-

- ing).
  During application care must be taken that no sweat drops onto the fresh Sikafloor<sup>®</sup> products. Wear head and wrist bands.
- For exact colour matching, ensure the Sikafloor<sup>®</sup> product in each area is applied from the same control batch numbers.
- Under certain conditions, underfloor heating or high ambient temperatures combined with high point loading, may lead to indentations in the resin.
- If temporary heating is required do not use gas, oil, paraffin or other fossil fuel heaters, these produce large quantities of both CO<sub>2</sub> and H<sub>2</sub>O water vapour, which may adversely affect the finish. For heating use only electric powered warm air blower systems.
