- Sika ViscoFlow[®]-3500 (GB) shall not be added to dry cement.
- Excessive water addition or overdosing may cause bleeding or segregation.
- Support from our Technical Service Department is recommended.
- If frozen and / or if precipitation has occurred, Sika ViscoFlow®-3500 (GB) may be used after thawing slowly at room temperature followed by intensive remixing.
