If the recommended processing temperatures are exceeded over a fairly long period, additionally the formation of hazardous organic decomposition products is possible. It is recommended to remove such vapours e.g. by using an efficient exhauster.

In case of inadequate ventilation wear respiratory protection. Respirator selection must be based on known or anticipated exposure levels, the hazards of the product and the safe working limits of the selected respirator.
