APPLICATION INSTRUCTIONS

Application Method/Tools

The standard rules of good concreting practice, concerning production and placing, are to be followed. Laboratory trials shall be carried out before concreting on site, especially when using a new mix design or producing new concrete components.

Fresh concrete must be cured properly and curing applied as soon as possible.

Notes on Application/Limitations

- When using Sika ViscoFlow®-4000 (GB) a suitable mix design has to be taken into account and local material sources shall be trialled.
- Sika ViscoFlow®-4000 (GB) shall not be added to dry cement.
- Excessive water addition or overdosing may cause bleeding or segregation.
- Support from our Technical Service Department is recommended.

Frost:

If frozen and / or if precipitation has occurred, Sika ViscoFlow®-4000 (GB) may be used after thawing slowly at room temperature followed by intensive remixing.
