PRODUCT DESCRIPTION

Mineral Helastopol P 4,5 kg/m² is an SBS modified bituminous roof waterproofing membrane with a weight of 4.5 kg/m². It is reinforced with a non-woven polyester fabric dimensionally stabilised with glass fibre and is flexible at -15 °C. The top surface is coated with mineral granules, which allows the permanent exposure to UV radiation. The underside of the product has a burn-off film for easy torch-application.

USES

Mineral Helastopol P 4,5 kg/m² is used as a water-proofing membrane for:

- Balconies and terraces
