- Dissolves thermoplastics that are not resistant to solvents (e.g. polystyrene, polycarbonate, acrylics).

- Use solvent resistant gloves and eye protection glasses during application.
- Small amounts of cleaner can degrade thermoplastic surfaces.
- SikaRoof® Cleaner 2000 contains volatile and flammable solvents.
- When applied in enclosed rooms, sufficient ventilation must be provided. In addition do not smoke and avoid open flames.

#### **APPLICATION**

Soak a white cotton cloth with the cleaner and remove contamination from seam overlap surfaces. Do not apply cleaner directly onto the membrane surface. For difficult residue removal, a Scotch Brite pad can also be used. Dry thesurface of the membrane overlap with a white cotton cloth. To remove mineral contamination from the membrane surface the SikaRoof® Cleaner 2000 may be diluted with water.
