Retardan<sup>®</sup> L is a high-performance set retarder for calcium sulfate (gypsum) based binding materials.

#### USES

Retardan® L provides excellent performance in the adjustment of setting time and workability of calcium sulfate binders.

The product is especially suitable for the production of gypsum boards (plasterboards / wallboards), fiber boards, partition panels, ceiling tiles and gypsum blocks.
