#### PRODUCT DESCRIPTION

SikaRoof® Aluminium Edge Trim UK is required for use on exposed roof system edges to restrain the leading edge of a green roof build up. They can be cut to length, and matching corner pieces are available for ease of installation.

#### USES

- As a separator between the substrate and gravel margin where required
- As water-permeable upstand at the eaves edge of monopitched roofs up to max. 5° roof pitch
- Not suitable for use as a structurally effective gravel retainer for pitches of > 5°

- Permeable to water with 6 mm Ø holes in the vertical leg
